

ARP ESSER Health and Safety Plan Guidance & Template

Section 2001(i)(1) of the American Rescue Plan (ARP) Act requires each local education agency (LEA) that receives funding under the ARP Elementary and Secondary School Emergency Relief (ESSER) Fund to develop and make publicly available on the LEA's website a Safe Return to In-Person Instruction and Continuity of Services Plan, hereinafter referred to as a Health and Safety Plan.

Based on ARP requirements, 90 percent of ARP ESSER funds will be distributed to school districts and charter schools based on their relative share of Title I-A funding in FY 2020-2021. Given Federally required timelines, LEAs eligible to apply for and receive this portion of the ARP ESSER funding must submit a Health and Safety Plan that meets ARP Act requirements to the Pennsylvania Department of Education (PDE) by Friday, July 30, 2021, regardless of when the LEA submits its ARP ESSER application.

Each LEA must create a Health and Safety Plan that addresses how it will maintain the health and safety of students, educators, and other staff, and which will serve as local guidelines for all instructional and non-instructional school activities during the period of the LEA's ARP ESSER grant. The Health and Safety Plan should be tailored to the unique needs of each LEA and its schools and must take into account public comment related to the development of, and subsequent revisions to, the Health and Safety Plan.

The ARP Act and U.S. Department of Education rules require Health and Safety plans include the following components:

- How the LEA will, to the greatest extent practicable, implement prevention and mitigation
 policies in line with the most up-to-date guidance from the Centers for Disease Control
 and Prevention (CDC) for the reopening and operation of school facilities in order to
 continuously and safely open and operate schools for in-person learning;
- 2. How the LEA will ensure continuity of services, including but not limited to services to address the students' academic needs, and students' and staff members' social, emotional, mental health, and other needs, which may include student health and food services;
- 3. How the LEA will maintain the health and safety of students, educators, and other staff and the extent to which it has adopted policies, and a description of any such policy on each of the following safety recommendations established by the CDC:

- a. Universal and correct wearing of masks;
- b. Modifying facilities to allow for <u>physical distancing</u> (e.g., use of cohorts/podding);
- c. Handwashing and respiratory etiquette;
- d. <u>Cleaning</u> and maintaining healthy facilities, including improving <u>ventilation</u>;
- e. <u>Contact tracing</u> in combination with <u>isolation</u> and <u>quarantine</u>, in collaboration with State and local health departments;
- f. <u>Diagnostic</u> and screening testing;
- g. Efforts to provide COVID-19 vaccinations to school communities;
- h. Appropriate accommodations for children with disabilities with respect to health and safety policies; and
- i. Coordination with state and local health officials.

The LEA's Health and Safety Plan must be approved by its governing body and posted on the LEA's publicly available website by July 30, 2021.* The ARP Act requires LEAs to post their Health and Safety Plans online in a language that parents/caregivers can understand, or, if it is not practicable to provide written translations to an individual with limited English proficiency, be orally translated. The plan also must be provided in an alternative format accessible, upon request, by a parent who is an individual with a disability as defined by the Americans with Disabilities Act.

Each LEA will upload in the eGrants system its updated Health and Safety Plan and webpage URL where the plan is located on the LEA's publicly available website.

The ARP Act requires LEAs to review their Health and Safety Plans at least every six months during the period of the LEA's ARP ESSER grant. LEAs also must review and update their plans whenever there are significant changes to the CDC recommendations for K-12 schools. Like the development of the plan, all revisions must be informed by community input and reviewed and approved by the governing body prior to posting on the LEA's publicly available website.

LEAs may use the template to revise their current Health and Safety Plans to meet ARP requirements and ensure all stakeholders are fully informed of the LEA's plan to safely resume instructional and non-instructional school activities, including in-person learning, for the current school year. An LEA may use a different plan template or format provided it includes all the elements required by the ARP Act, as listed above.

1. How will the LEA, to the greatest extent practicable, support prevention and mitigation policies in line with the most up-to-date guidance from the CDC for the reopening and operation of school facilities in order to continuously and safely open and operate schools for in-person learning?

The Farrell Area School District (FASD) will continue to monitor the recommendations made by the Pennsylvania Department of Education, Governor of Pennsylvania, Pennsylvania Department of Health, and CDC. Those recommendations will be implemented to the greatest extent practicable. The FASD will follow all orders given by the aforementioned authorities. We will continue to implement cleaning, sanitizing, and health and safety protocols in order to allow us to open, remain open, and operate safely. The FASD will also continue to monitor and assist with contact tracing, in response to known positive COVID cases, and in order to mitigate its' spread.

2. How will the LEA ensure continuity of services, including but not limited to services to address the students' academic needs, and students' and staff members' social, emotional, mental health, and other needs, which may include student health and food services?

As a result of our technology plan, the Farrell Area School District is a one-to-one device school district. Students have Chromebooks or iPads, and each teacher has been equipped with a Chromebook which will allow education to continue to be delivered (remotely) in the event of a school closure. In addition, the FASD has purchased hotspots which can be utilized by students who do not have internet access.

FASD will continue to support students with social emotional, and mental health needs through a variety of means that will include, but may not be limited to: SAP (Student Assistance Program), Guidance Counselors, SCORE, Social Worker (if hired), and Mercer County Behavioral Health. Mercer County Behavioral Health is also available to support staff members.

At the beginning of the pandemic, the FASD was able to establish remote meal sites for student breakfast and lunch distribution. Those sites (or others) will be used again, should the need arise.

Modifying facilities to allow for physical.distancing (e.g., use of cohorts/podding);	 FASD will continue to monitor the recommendations from the CDC, PA DOH, and PDE regarding social distancing and make adjustments as necessary. According to current CDC guidelines, class sizes will be arranged to allow for 3 feet social distancing where feasible. Primary classes may continue to eat breakfast and lunch in their classrooms in order to have smaller amounts of students in the cafeteria at any given time. Excess furniture, etc. will remain out of classrooms to allow for proper distancing to be maintained.
c. Handwashing and respiratory etiquette;	 Hand Sanitizer will be available and use of same encouraged in each classroom, office, and common area throughout the district. Handwashing/sanitizer before breakfast/lunch will be available to each student and encouraged. Signage will be posted throughout the District

Areas will be cleaned and disinfected (at least) daily. Regular cleaning/sanitizing of restrooms will occur throughout the day. Newly installed HVAC system provides adequate ventilation throughout the district Water fountains have been converted to hands-free (touchless) water bottle filling stations.
